The state oil major ONGC is starting services to transport its personnel to and fro from various oil platforms and drilling rigs in Mumbai High and Sadhav Anusha is one of the first to undertake this type of operations. The ship is replete with business class seats, dynamic positioning system, gyro stabiliser and motion compensated gangway. It is expected to relieve the stress on services provided by helicopters which have been traditionally used for the employee/passengers. Sadhav Anusha ushers in a New Era of Safe & Efficient Offshore Crew Transfer Operations.

Shri Mathavan Chandran, Executive Director ONGC said, "With the introduction of the state of the art vessel, the passengers will be safe, secured and comfortable for travel from and to offshore installations".
